Terms of Use

Rapideditor.org is available online under the website https://rapideditor.org (hereinafter referred to as the "Website"). These Terms of Use ("Terms") govern the use of the Website (the "Services"). The required registration process is described on the OpenStreetMap website. OpenStreetMap is a community-driven project to create a free and editable map of the world. We encourage you to review the Terms of Use and Privacy Policies applicable to OpenStreetMap or any third party to whom you choose to share your personal information directly.

Content

In general, there are two types of content accessible through the Services:

• Except with respect to the Third-Party Content (defined below), content created by us that We make available to you as part of the Services (the "Services Data"). Services Data include, for example, mapped predicted features that Our artificial intelligence has identified, such as roads, pathways and buildings, among many others. The Services Data is made available to you under the terms of the MIT license (https://opensource.org/licenses/MIT), provided that you not remove any copyright notices, identifying marks or any metadata that attributes the source of any such Services Data. If there are existing "digitalglobe" tags in the metadata of the Services Data, you shall also include attribution in the metadata file for any derivative works by either (i) tagging each new road with "source=digitalglobe" or "source=maxar", or (ii) adding "source=digitalglobe" or "source=maxar" to the changeset comments.

- Content that you configure the Services to download from an external server for use with the Services (the "User-Originated Data"). When you configure the Services to use User-Originated Data, you agree that you are solely responsible for:
 - ensuring you have all rights and authorizations needed to use the external data source you are downloading form for your contemplated use with the Services;
 - o complying with any terms or conditions applicable to both the service that hosts the external data and any terms governing the use of that data itself; and
